SUBMISSION OF ARTICLES IN THE ACADEMIC JOURNAL OF THE SUPERIOR SCHOOL OF THE PUBLIC PROSECUTION

The General Director of the Superior School of the Public Prosecution, in the use of its statutory attributions, establishes the guidelines for the authors of the Academic Journal of the Superior School of the Public Prosecution, standardizing the process for publishing articles, with the following objectives and structure:

- **Presentation**

A Academic Journal of the Superior School of the Public Prosecution is an official publication of SSPP and meets all formal requirements for scientific recognition, as it is duly registered with the Brazilian Institute of Information in Science and Technology IBICT, with the International Standard Serial Number (ISSN).

- **Schedule**

The call for scientific articles to compose the Academic Journal of the Superior School of the Public Prosecution, regarding the selection of scientific articles for publication in number II - year XII - 2020 is in progress and the receipt of the articles will take place until October 8th, 2020 .

The publication of the Academic Journal of the Superior School of the Public Prosecution occurs every six months, as in electronic and as physical versions.

- **Guidelines for authors**

The SSPP publishes, on its website, a notice for the submission of proposed articles, which contains the deadlines for receipt and publication.

Articles sent to SSPP must comply with the deadline set in the Notice of SSPP which will allow their analysis, normalization, correction and publication.

Texts will be automatically rejected if they do not comply with the format required by both the Public Notice and the Rules of the Academic Journal of the Superior School of the Public Prosecution, available on the website:

The articles must be authored by PhD, masters and specialists degrees, accepting bachelor's and undergraduate students as co-authors of PhD, masters and specialists.

Omitted cases will be decided jointly by the Editorial Board of the Academic Journal of the Superior School of the Public Prosecution.

- **Submission of articles**

The version of the article to be submitted must be sent to the email: revistaacademica.selecao@mpce.mp.br in pdf and Microsoft Word formats (.DOC or .DOCx) without identification of the author(s) in the text such as in the in the properties of the file to be submitted as well. Attached, in order to have a file that ensures the Evaluation by “Blind Peers”.

The writer must also send email, separately, to revistaacademica.esmp@mpce.mp.br, with an attachment of the complete article submitted in pdf, with identification of the authors, which must include, after the title, the name of the author(s). The title of your article must appear expressly in the body of the email, accompanied by the identification of the authorship of the scientific article.

The version with identification must be sent with a footnote for each author, which must include: professional qualifications, academic level, email, link to the *curriculum lattes* and ORCID. The sole sending of the article to the magazine's email does not guarantee its publication.

The articles sent must have their content focused on topics of interest to Public Prosecution

The texts in Portuguese must be written according to the rule for submitting articles from the Brazilian Association of Technical Standards - ABNT - NBR6022, from May 2003 and foreign articles must be based on the equivalent ISO rule, always complying with publication standards of the journal, as per the public notice for each publication.

Articles must have a minimum of 15 (fifteen) and a maximum of 20 (twenty) pages, typed in Times New Roman, size 12, obeying spacing between lines of 1.5, left and top margins with 3 cm and margins right and bottom with 2 cm. Paragraphs must be in the justified position and must be indented by 1.25 cm.

The article may also be in a foreign language (English or Spanish), having to present: title, abstract and keywords, both in the vernacular and in Portuguese. The article must contain three to five keywords separated by a period.

The abstract must be a maximum of 100 words. The article in a foreign language (English or Spanish) must also include the Portuguese version. The Abstract must indicate the objective, the method and the result achieved by the research.

Articles must have the following content: introduction, development, final considerations and references. If there are subtitles, they must be clearly indicated. All topics must be highlighted according to ABNT rules.

Citations throughout the text must follow the ABNT NBR10520 standard or equivalent ISO standard.

Authors of articles accepted requiring corrections will have a deadline established in the schedule for each public notice, always being considered calendar days.

The SSPP may also request the author to make the necessary changes if the article is in disagreement with the journal's standardization standards. The author must comply with the schedule, mandatorily. Articles outside the standards indicated in the notice will not be accepted.

The published articles do not necessarily reflect the opinion of the magazine, or of the SSPP.

- **Copyright matters**

In case of approval, the author will be asked to sign the proper Form of DECLARATION OF INEDITISM AND ASSIGNMENT OF COPYRIGHT on behalf of SSPP and a Term of agreement with the publication of his article by electronic means available on the website of SSPP. Copyrights or any other type of remuneration will not be due for the publication of the articles in the Academic Journal of the Superior School of the Public Prosecution.

Omitted cases will be decided jointly by the Editorial Board of the Academic Journal of the Superior School of the Public Prosecution.
